## Expression of Interest (EOI)

BDA is inviting Expression of Interest (EOI) for the works of “**Data extraction service from existing DMS – approach and commercials**”

### **1. INTRODUCTION AND BACKGROUND:**

BDA had issued Work Order No. BDA/Scanning/2009-2010 dated 23.12.2009 to **3i Infotech Ltd., No 6/2, Union Street, Off Infantry Road, Bangalore - 560001** for Scanning, Indexing and Cataloguing of files of BDA. The work involved Pre-scanning activities, scanning, Quality control, Indexing and Profiling, Meta data entry, and providing Meta data on DVDs and or in harddisks. Also should provide Document Management System, as a repository of scanned document images for online retrieval.

### **2. AS-IS:**

From 2010 to 2011, around 56 lakhs pages were scanned and the Document Management System (DMS) was provided 3i InfoTech, as a repository of scanned document images for online retrieval. Further, the scanning work was awarded to M/s Mathenson for year 2012 and to M/s BEST DBM Solutions from there on till 2015. The DMS application of 3i InfoTech was continued as repository of scanned document images for online retrieval. From 2015, the DMS server crashed and only scanning activity is continued by M/s BEST DBM Solutions. The documents scanned from 2010 to 2015 are stored in DMS server in encrypted format and the same has been taken as backup. The existing DMS backup data along with database in MySQL is of about 1.7TB available with BDA.

### **3. SCOPE OF WORK:**

The scope of work involves

- Extraction of encrypted data available as backup data with BDA and in the existing DMS server to TIF (viewable) images along with indexes on as is condition basis.
- Provide Document Management System (DMS) application, a repository of scanned document images for online retrieval having indexing, profiling, meta data entry, viewing of scanned images available in TIF, pdf, etc., along with necessary Servers, hardware, etc., to be hosted in BDA

### **4. PROJECT PERIOD:**

The total duration is one months from the date of award. The participating bidders are required to complete the extraction of data to TIF (viewable) images along with indexes within one month from the date of award.
